Property

A prominent end of terrace detached unit within a gated and fenced estate. The unit consists of a steel portal frame construction and mono-pitched roof. The ground floor includes a reception/ office, WC, electric roller shutter door and roof lighting.

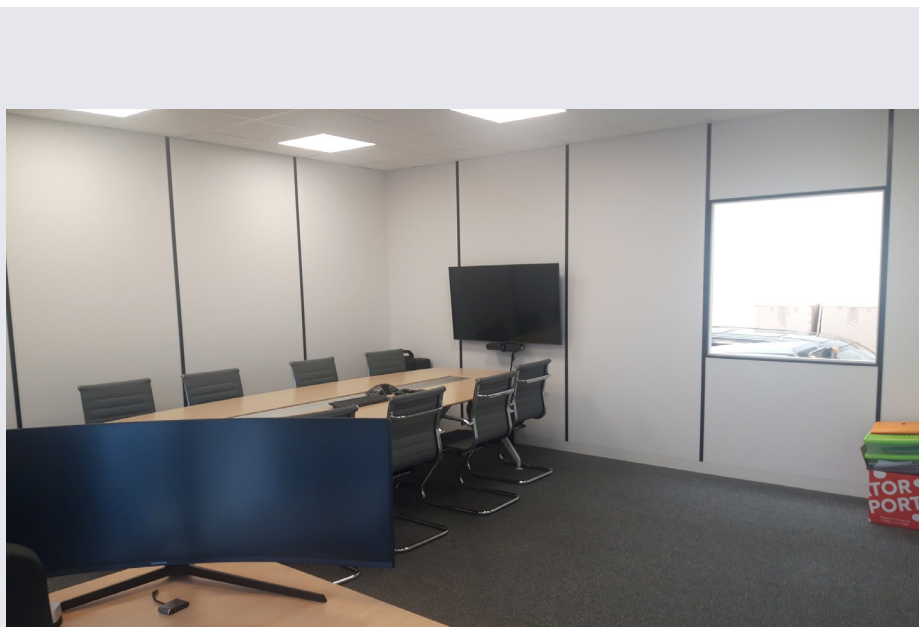
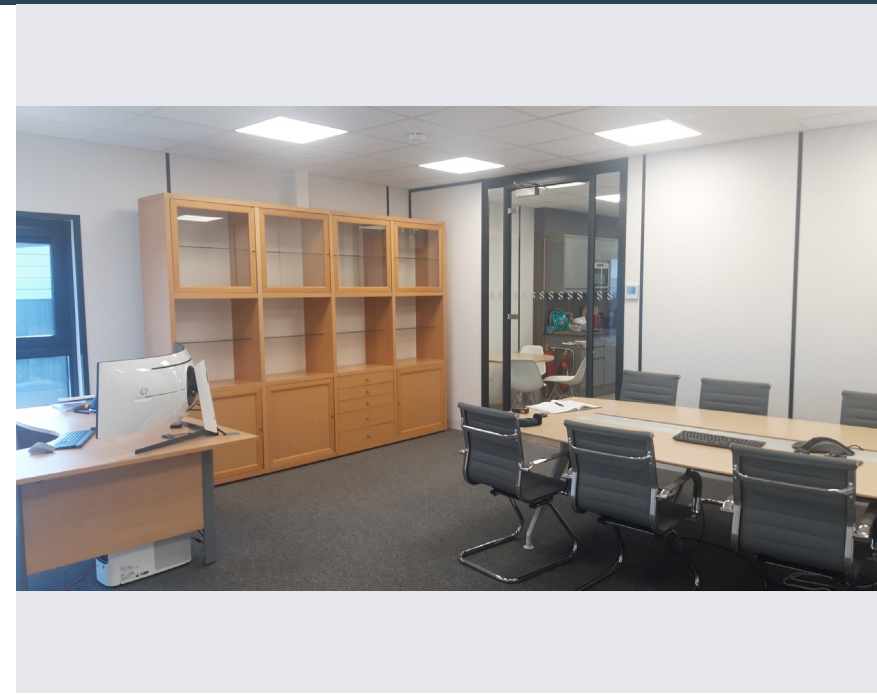
Location

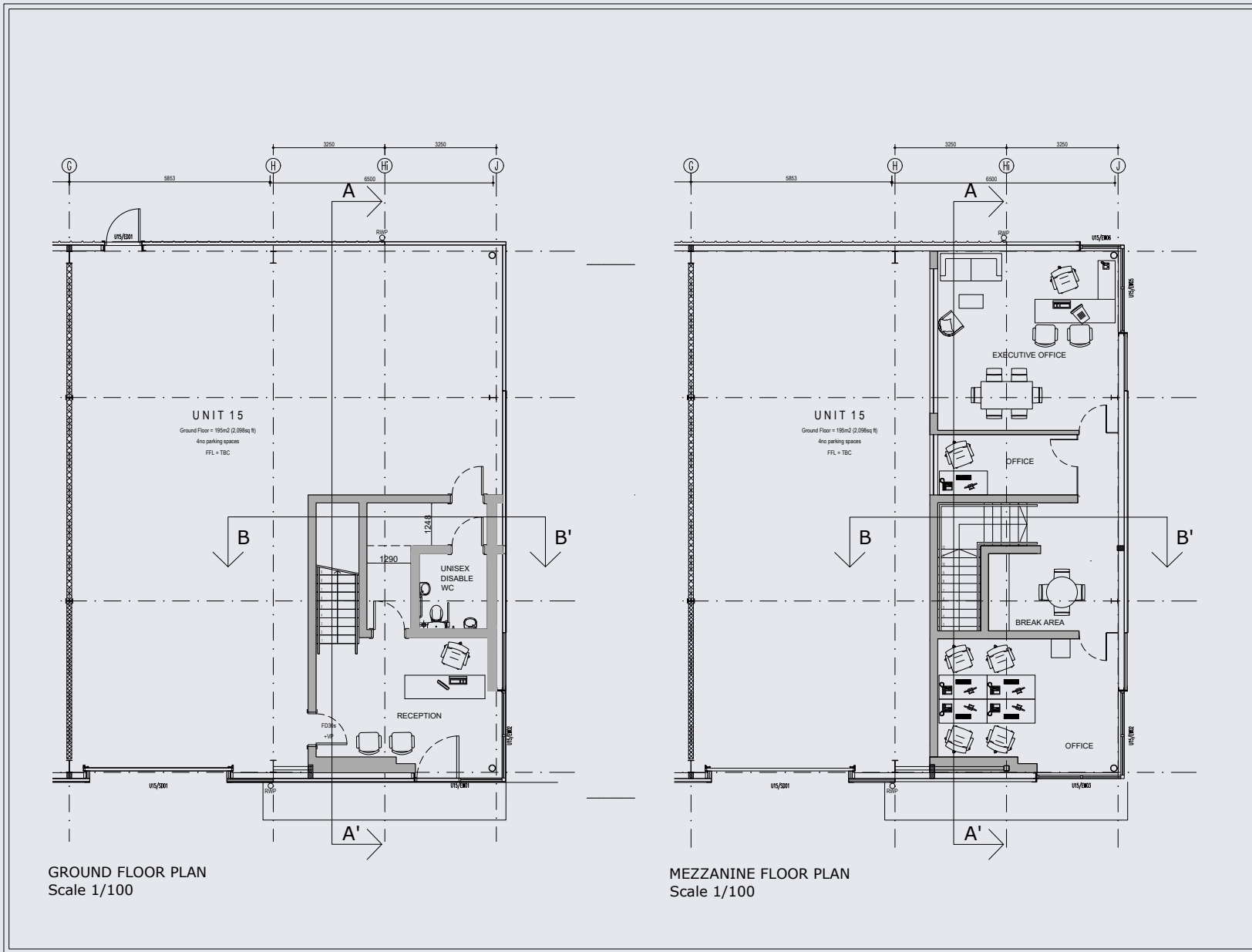
