The fantastic family run Canonbury Yard development is located on New North Road, between Baring Street and Essex Road, just outside of the congestion charging zone.

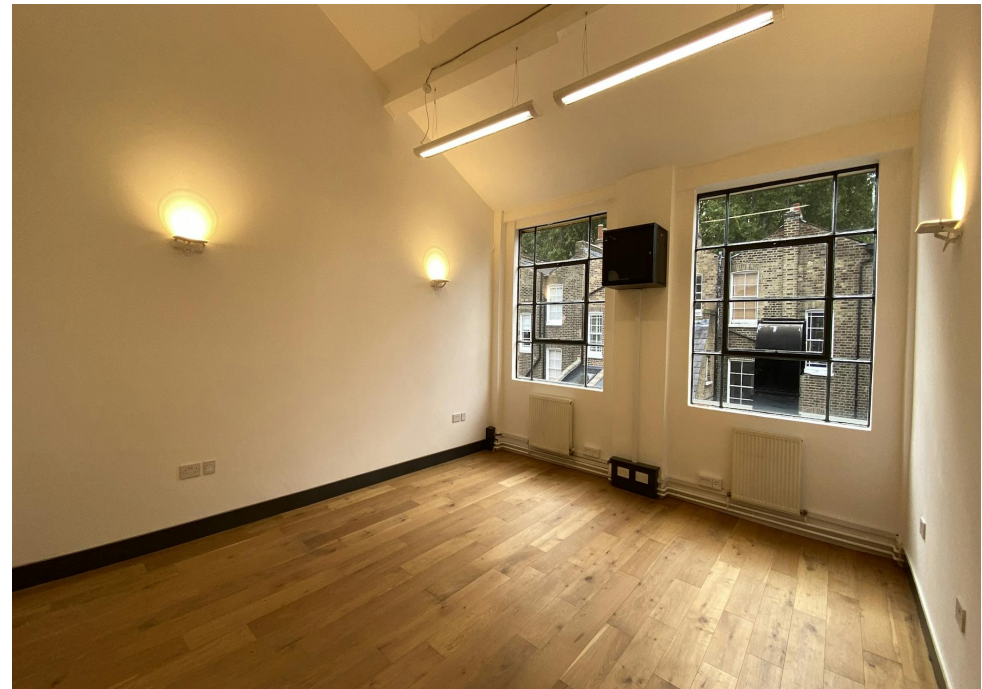
The estate attracts a mix of occupiers from light industrial and manufacturing, to fashion, design and marketing.
