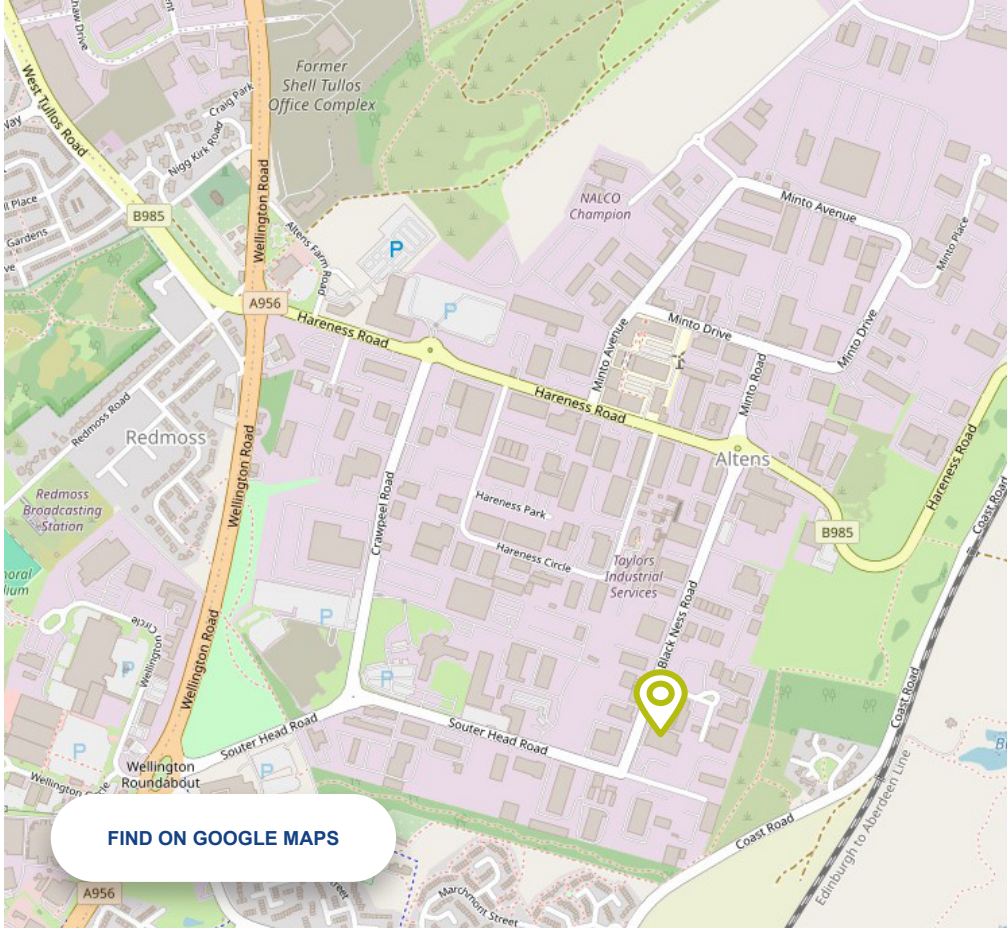

## LOCATION

The property is located within a modern industrial development comprising 12 units known as the Braehead Centre on the eastern side of Blackness Avenue within Altens Industrial Estate, situated to the south of Aberdeen City Centre.

The development provides easy access to the City via Wellington Road and to the south of Aberdeen City Centre.

Occupiers within the estate include; 2Stabilise, NXG Group, Muller, CLR Sales and IT Sameday.

## DESCRIPTION

The subjects comprise a modern industrial unit of steel portal frame construction clad in profile metal sheeting with pitched roofs, incorporating translucent panels for natural light. The unit has aluminium framed double-glazed windows at the front of the premises and internally the unit comprises workshop and office accommodation with a toilet.

Vehicular access is provided to the unit via an electrically operated up-and-over steel roller shutter door measuring 4 metres in width and 4 metres in height. The eaves height of the building is 5 metres.

The premises have been measured in accordance with the RICS Code of Measuring Practice (Sixth Edition) and the following gross internal floor areas derived: -
