Description

The property comprises a self-contained ground floor retail unit with ancillary basement accommodation, kitchenette and WC facilities.

The premises were previously occupied as a hairdressing and beauty salon since 2015, most recently let in 2020 on a 5-year fixed term lease at a rent of £14,400 per annum, with the tenant vacating in October 2025.

The unit is now offered with vacant possession, providing flexibility for either immediate occupation or re-letting. The existing long lease allows for A1 retail use only and any other use would be subject to a formal variation to the lease and Freeholder consent.

There are no residential upper parts or ground rent payable.

Location

The property is situated on Anerley Road in Crystal Palace, a well-established South East London location characterised by a mix of independent retailers, office occupiers and residential accommodation.

The property is located approximately 0.4 miles (7-8 minute's walk) from Crystal Palace Station, which provides excellent regional and London-wide connectivity. Crystal Palace Station offers both London Overground and National Rail services.

The area is also well served by local bus routes along Anerley Road, providing access to Penge, Beckenham, Sydenham and Bromley.

Crystal Palace 0.2 Miles



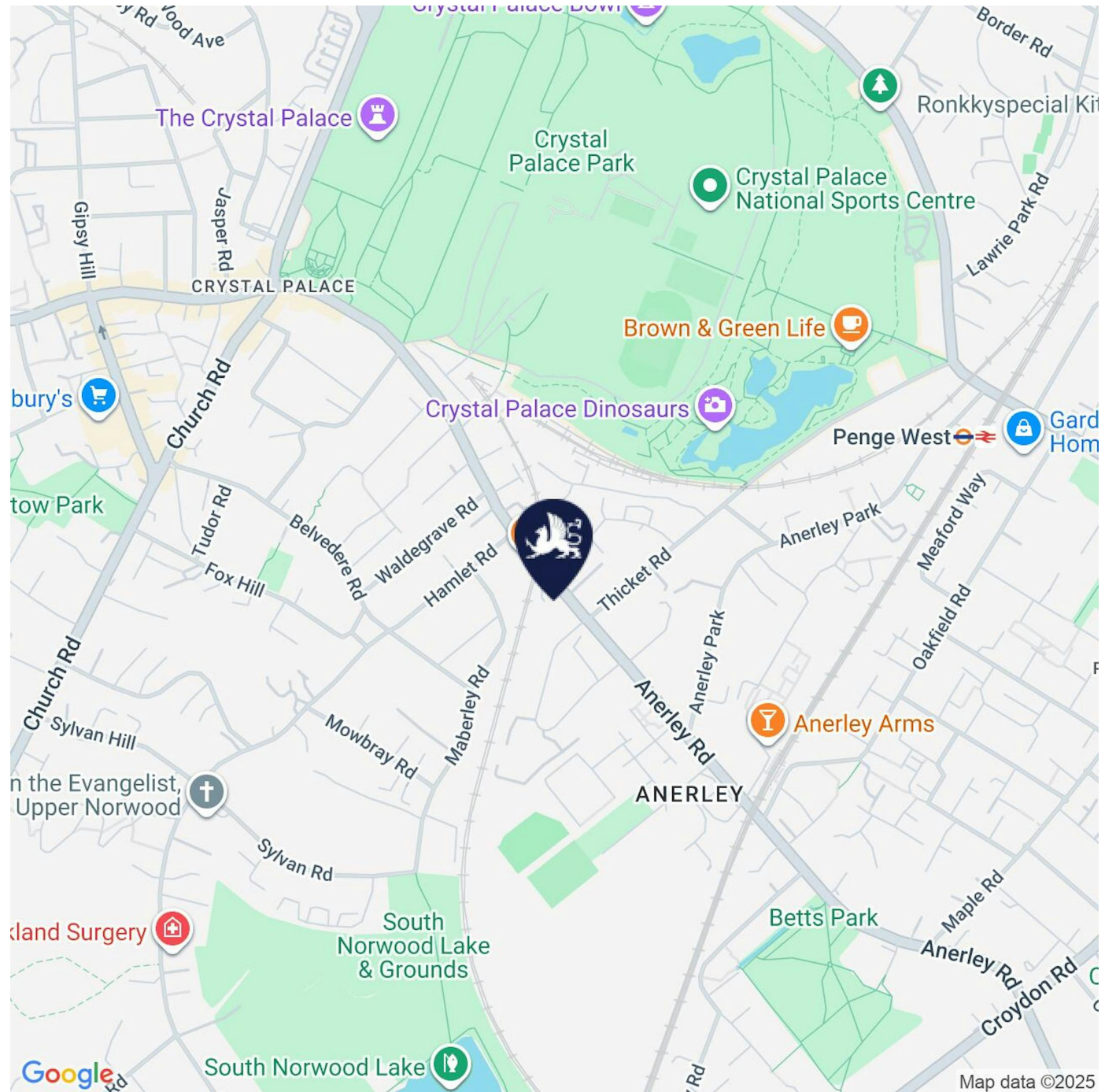
Anerley 0.3 Miles
